A GOVERNANCE

BBI The Australian Institute of Theological Education (BBI-TAITE) is a not-for-profit public company limited by guarantee and registered, pursuant to the Corporations Act 2001 (Cth), as a Charity with the Australian Charities and Not-for-Profits Commission (ACNC). It is a wholly owned subsidiary of The Educational Centre for Christian Spirituality Limited.

BBI-TAITE gained initial registration as a Higher Education Provider (HEP) on 1 September 2016. Following the TEQSA 2021 category reclassification, the Institute is now an Independent Higher Education Provider (IHEP). Due to the impact of COVID-19, TEQSA extended the Institute's registration renewal date to 1 September 2025.

OBJECTS OF THE COMPANY

(Constitution of BBI The Australian Institute of Theological Education, Section 3)

Our company Objects are an iteration of the original intent of the trust: "... to undertake the education of persons in Christian spirituality and adult education and to give to any person who is desirous of undertaking or continuing their education in Christian spirituality and adult education the opportunity to do so" (Trust Deed (A.) 11/6/1979).

As set out in the BBI-TAITE Constitution, the objects for which the Company is established are:

- (a) To operate, maintain and promote the Company in accordance with the mission of the Roman Catholic Church, its beliefs, traditions and practices.
- (b) To embody and promote a Catholic ethos with an ecumenical spirit, engaging faith, culture and society.
- (c) To engage and teach students consistently with high quality educational methods and practices, offering opportunities for growth in knowledge and further transformation.
- (d) To foster and promote excellence in teaching and scholarship that is grounded in and contributes to contemporary research and draws from the rich intellectual life of Catholic and other faith traditions, so as to further the goals of theological learning and human development.
- (e) To deliver educational opportunities in Christian spirituality and adult faith formation.
- (f) To deliver quality education through a variety of partnerships, linkages and cooperative ventures, including with other tertiary institutions.

MISSION STATEMENT

BBI-The Australian Institute of Theological Education's mission is to provide quality Catholic theological education to all members of the community with a commitment to teaching excellence grounded in contemporary and applied research.

STRATEGIC DIRECTIONS

Our **Strategic Plan** is presently under revision, although several elements that constitute a strategic plan are in play and are taken up in the **Strategic Directions**:

- 1. Provide online TEQSA accredited tertiary education courses in theology and related disciplines: Theology, Religious Education, Leadership & Governance, and Canon Law
- 2. Provide adult faith and leadership development courses and opportunities: online adult faith and leadership short courses, adult faith and leadership courses face to face, lecture series, online retreats, correspondence courses (in particular for prisoners)
- 3. Provide conferences, eConferences and learning events that complement the tertiary courses and are accessible for adult faith and leadership development, and
- 4. Provide events and products that offer service to the church through partnerships with community and industry bodies.

The BBI-TAITE Board of Directors undertakes the governance of the Institute. The Board has two sub-committees that contribute to the oversight of the Institute: the Audit and Risk Committee and the Academic Board. At the beginning of 2021 BBI-TAITE commenced preparation for the seven-yearly TEQSA reregistration renewal process. The Board of Directors agreed to engage Adelaide consultants *dve Business Solutions* to review BBI-TAITE's corporate and academic governance structures, processes and procedures. In November 2021, *dve Business Solutions* produced two independent reports, the *External Review of Corporate Governance and Academic Governance* by Professor John Jenkins, and the *TEQSA Health Check* by Danielle Baird. The Board of Directors reviewed the reports and agreed to implement all the recommendations. The Directors agreed to revise the Constitution and develop a Governance Charter for approval by June 2022. The remainder of the recommendations will be met by the end of 2022.

WORKPLACE

Although located in the Caroline Chisolm Centre at Pennant Hills, effectively, the Institute has moved to a small footprint physical location with staff and faculty working remotely. This approach enables us to embrace the online environment, draw staff and faculty from across Australia, and move towards a fully digital library collection.

OPERATIONAL ADMINISTRATIVE SYSTEMS

We use the following systems for BBI-TAITE's various administration functions to ensure effective and efficient operational management:

Operating system

Microsoft Office 365

Accounting

Xero: Cloud-based accounting software system which allows BBI-TAITE to send invoices, pay bills, reconcile bank transactions etc..

Student Services

Paradigm: This is BBI-TAITE's Student Management System supports all areas of student administration, including applications, admission, enrolments, progression and graduation, document generation and management, communications tracking, student accounting, government compliance and comprehensive reporting.

The Tertiary Collection of Student Information (TCSI, pronounced 'taxi'): this government reporting system allows BBI-TAITE to report student data directly to the Australian Government. This is done directly via an application programming interface (APIs), sending data from Paradigm to the Australian Government with minimal manual processing.

MyEquals: Australia and New Zealand's official tertiary credentials platform for universities, TAFEs and tertiary education providers. It makes it easy for Education Providers, Learners and Verifiers to view, share and verify certified tertiary credentials online.

Digitary: a digital certificates credentials platform for non-accredited awards.

Events and Marketing

Salesforce (CRM) is BBI-TAITE's Customer Relationship Management system. The Institute saves all current and potential student details in Salesforce, including potential students/customers and key contacts for all the areas we integrate and work with. In addition, Salesforce can integrate with Campaign Monitor to send marketing/advertising material to focus groups/cohorts.

Eventbrite is an event management platform that allows BBI-TAITE to market and sell tickets to our various events.

Campaign Monitor is a marketing email platform that allows for customisation and template management.

SurveyMonkey allows BBI-TAITE to create and administer surveys to students, event attendees, target interest groups etc.

EDUCATIONAL PLATFORMS & PROGRAMS

BBI-TAITE subscribes to two online platforms for learning and teaching.

Blackboard: The Institute uses the Learning Management System, Blackboard, to deliver accredited courses and several non-accredited courses requiring a higher degree of interaction.

Teachable: BBI-TAITE uses Teachable for our Adult faith online courses. Teachable automates enrolment, fee payment, progression through a course, and the provision of a certificate of completion.

LIBRARY

The physical library collection contains approximately 22,000 books, journals, videos and graphic materials managed by **Follet Destiny**. In addition, we hold subscriptions to **ProQuest Ebook Database** and the **EBSCO Journal Database**, providing access to electronic books and journals. The library can source material from libraries across Australia and New Zealand through Libraries Australia and the Document Delivery Service.

ACCREDITED COURSES

The Institute offers a targeted set of nested accredited courses, set out earlier in this report. These programs service the faith development needs of teachers in catholic schools and catholic organisations, and appeal to members of the faithful. The Institute offers these courses at AQF levels 8 and 9, and are accredited through the Tertiary Education Quality and Standards Agency (TEQSA) until 1 September 2025. The courses attract Fee-Help for students.

BENCHMARKING

BBI-TAITE participates in two surveys funded by the Australian Government Department of Education, Skills and Employment and administered by the Social Research Centre. The surveys are conducted by the Quality Indicators for Learning and Teaching (QILT) Survey Team as follows:

- Graduate Outcomes Survey (GOS) provides information about the quality of education provided and on the labour market outcomes and further study activities of graduates. The intent and spirit of the GOS is to survey graduates of Australian higher education institutions approximately four to six months post completion of their course.
- The Student Experience Survey (SES) is the only comprehensive survey of current higher education students in Australia. Around 180,000 undergraduate students and 83,000 postgraduate coursework students from Australian universities and non-university higher education institutions (NUHEIs) participated in the 2019 SES. The survey collects information that helps both higher education institutions and the government improve teaching and learning outcomes, and reports on multiple facets of the student experience.

The Institute has begun conversations with the Sydney College of Divinity to enter a formal benchmarking agreement.

 Internal surveys of units are offered each session for student feedback: this information is fed back to each lecturer.

The Executive Team monitors survey outcomes, benchmarking them against curriculum, processes and other activities.

DIGITAL QUALIFICATIONS

- Accredited awards: Upon graduation from accredited awards, BBI-TAITE graduates receive
 digital qualifications through My eQuals, the official Australian tertiary credentials platform
 governed and operated by participating Australian and New Zealand tertiary providers.

- Adult faith development programs: Participants in the adult faith and leadership development programs run on the **Teachable** site receive a certificate generated from the Teachable site.

GRADUATION

The Institute has moved to a model of continuous graduation, with students eligible to graduate receiving their graduation documents after each session. Typically, the students eligible to graduate at the end of any Trimester will be approved to graduate at the next meeting of the BBI-TAITE Board of Directors.

True to our origins in the correspondence courses and programs of the Centre for Spirituality, Randwick, our non-accredited programs have wide application in spiritual formation, faith education, and the ongoing accreditation of teachers and health professionals. The programs are:

CORNERSTONES Program

In 2021 we entered into an MoU with Toowoomba Catholic Schools (TCS) to provide a two-year program for the induction of new teachers into the Catholic School system. The program comprises eight modules, each consisting of four sessions, with one module taught per school term. The topics, content and pedagogy were designed collaboratively between TCS (Dr Ken Avenell) and BBI-TAITE. The program is accepted in the Toowoomba diocese as a pathway to accreditation to teach Religious Education. DISCIPLES AND LEADERS Program

At the request of the Bishop of Toowoomba, we have developed the *DISCIPLES AND LEADERS* program for training lay leaders in parishes. This program seeks to develop the theological capacity of lay members of the congregation, starting from an adult faith level.

About the Journal - BBI

Review of Religious Education and Theology is a peer-reviewed, open-access journal that explores how religious education and theology as disciplines inform each other. The nature of this relationship is dynamic and premised on the understanding that religious education and theology are both mutually enriching and deeply contextual. The journal publishes original research that explores classroom practice, teacher formation, conceptual issues that frame how religious education and theology can be understood, and other related issues. Statement relating research activity to teaching

My current research and teaching projects are tightly intertwined. The principal focus of my research is developing a spirituality of flourishing in midlife.
